REGULAR SELECTBOARD MEETING THURSDAY, SEPTEMBER 1, 2016 AT 5:30PM

Present: Steve Barrup, Jerry Waterman, Richard Gosselin, Denise Daigle, Mike Paradis, Charlie Pronto, Jayne and Barry Sahagian, Fred Baraw, Bobby Lemay, David Ciliberto

Steve called the meeting to order at 5:30PM and introduced those present.

Jerry made a motion to approve the minutes of the 8/4 meeting, seconded by Rick and passed on a voice vote.

Appearances by local citizens/visitors – no report

Representatives of the Newport Ambulance, Charlie Pronto and Mike Paradis, were here to discuss the town signing a contract for their services. The selectboard reviewed this contract. Some discussion followed. Charlie and Steve will change/modify the contract for Newport town and this will be further discussed at a future board meeting.

Road Commissioner report – Bobby Lemay and David Ciliberto were here to discuss the road situation on Bergeron Hill and the gravel ending up in David's driveway. Some discussion followed. The selectboard and Fred will go to Bergeron Hill after the board meeting tonight. Jerry and Steve did visit the property with Fred, Bobby and David. Some discussion followed. Selectboard voted that the decision on how to correct this issue is to be left up to Fred. Fred will contact Clark's Truck Center and set up a meeting with them to discuss the problems with the new truck.

Water/Sewer report – Fred reported that all is going well with both systems. Fred stated that Jeff Hoffer has started the pump tests on the two new wells.

Selectboard reviewed the letter from the Newport Center Cemetery Association requesting that the cemetery commission be dissolved and the town takes over this cemetery on Route 100. Steve made a motion to accept this letter, seconded by Rick and passed on a voice vote. The board asked Denise to send this letter to Bill Davies and ask that he begin this process.

Listers errors and omissions – regarding parcel id #VT105037 the listers recommend to the selectboard that this assessment be lowered to \$23,500.00 for the 2016 tax year. This was an error that occurred between the change of appraisal notice and the tax bill. Steve made a motion to accept the listers recommendation, seconded by Jerry and passed on a voice vote.

Unfinished/new business – selectboard reviewed a letter from David and Kristal Wilson regarding a complaint from Mr and Mrs Knight regarding unregistered vehicles. This letter is attached to these minutes.

Selectboard signed orders, reviewed bank statement.
